- CALL TO ORDER: The meeting was called to order at 8:15 a.m. by Steve Rebscher, Chair. Members

- 2. APPROVAL OF CLOSED SESSION AGENDA: Board Members approved the Closed Session Agenda (M/S Sloan, Sabec, unanimous).
- 3. PUBLIC COMMENTS ON CLOSED SESSION AGENDA: There were no comments.
- 4. AUTHORIZATION TO FORM A SCREENING/INTERVIEW COMMITTEE for a 5.5 hr/day Curriculum Specialist in the Lagunitas Waldorf Inspired Program for the 2013/14 school year, paid in full by the Waldorf Inspired Program. Motion: Richard Sloan moved to approve. Christopher Sabec, second. Motion carried, all ayes. Richard Sloan commended the administration for crafting a solution for the K/1 class in the program.

DISCUSSION ITEM:

Members of the Board of Trustees discussed superintendent services for the 2013/14 school year and directed Steve Rebscher, Board President, to begin negotiations with Bolinas Stinson School District for shared superintendent services with Larry Enos for the coming year.
