MINUTES FROM THE REGULAR MEETING  
OF THE BOARD OF TRUSTEES

Thursday, October 15, 2015

1. CALL TO ORDER: The meeting was called to order at 5:30 p.m. by Denise Bohman, Chair. Members present were Meegan Ochs-Potter, Denise Bohman, Richard Sloan, Christopher Sabec and Steve Rebscher. Also present were John Carroll, Superintendent, Laura Shain, Principal and Ana Mendez, Chief Business Official. Donna Henderson, Administrative Assistant, recorded the minutes.
2. APPROVAL OF CLOSED SESSION AGENDA: Board Members approved the Closed Session Agenda.
3. PUBLIC COMMENTS ON CLOSED SESSION AGENDA: There were no comments.
4. RECESS TO CLOSED SESSION: Board Members, Superintendent, and Principal recessed to Closed Session pursuant to Section 54957.6 Conference with Labor Negotiator, John Carroll, Certificated, Classified, Management/Confidential, requested by John Carroll, Superintendent.

summer. Phase 2 of the construction will focus on the outside, creating outdoor classrooms and one new play structure (SG campus) and the administrative building.

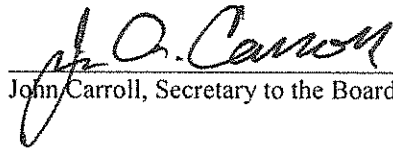
C. ACTION ITEMS
