Thursday, January 22, 2015

- 1. CALL TO ORDER: The meeting was called to order at 6:22 p.m. by Christopher Sabec, Chair. Members present were Meegan Ochs-Potter, Denise Bohman, Richard Sloan, Steve Rebscher, and Christopher Sabec. Also present were John Carroll, Superintendent, and Laura Shain, Principal. Donna Henderson, Administrative Assistant, recorded the minutes.
- 2. PUBLIC COMMENTS: Susan Shannon, SGVCC, read a lovely story about her experience with some of our middle school students and their encounter with an injured bird.
- 3. APPROVAL OF OPEN SESSION AGENDA: John Carroll, Superintendent, asked that Item 3 of the Human Resources/Action Agenda be re-posted atl the regular board meeting in February. M/S. The Board approved the open session revised agenda.
